- 8. Publication of Complaints/Discipline Process Workshop Follow Up

The Board attended a workshop on December 7 led by Mr. Howard Kushner, LLB, former B.C. Ombudsman. The focus of the workshop was on how the complex interrelationship between the fairness/integrity of investigatory processes and the clear public and professional interest in openness and transparency can play out when considering what to publish in relation to complaints and discipline matters. The workshop addressed legislative requirements for publication of complaints and discipline outcomes; publication trends among professions in B.C.; and options for the publication of complaints that are dismissed.

Staff will use the outcomes of the workshop to prepare a draft publication policy for review by the Board.

- 9. Canadian Dental Regulatory Authorities Federation (CDRAF)
 - Board Meeting October 11, 2012

The President, Vice-President and Registrar gave an update to the Board on this meeting.



Wellness Conference October 12, 2012

"On the Road to Wellness: Dealing with Addiction Disease in Dentistry" was a two-day conference hosted by the CDRAF on October 12. The President and Registrar gave a brief overview of the conference, which addressed how regulators should respond to cases where the registrant suffers from addiction or other medical impairments. Presenters at the conference included Dr. Graeme Cunningham, a former president of the College of Physicians and Surgeons of Ontario, whose personal life and career were damaged by his own addiction.

Estimates are that approximately 15% of the general population (including dentists) suffer from an addiction at some point in their lives. There is a heightened stigma for addicted healthcare professionals who must declare their addiction in order to gain access to programs of control and cure. There is growing recognition by health regulators that addiction must be treated as a disease, for which recovery pathways separate and apart from complaints and discipline must exist.

It is important to increase awareness of the disease; to identify those in need of treatment; and to provide that treatment as soon as possible. There is also need to develop a network of professionals willing to provide locum services to maintain a practice while the dentist receives treatment. The College is in discussion with CDSPI, the primary insurance provider for dentists, and the BC Dental Association (including the Dental Professional Advisory Program) as well as with CDRAF colleagues in an effort to enhance recovery pathways provincially and at the national level.

Report on Botox & Dermal Fillers

The Board received the report by the national *Ad Hoc* Committee on Botox and Dermal Fillers in Dental Practice. The committee's mandate was to summarize what a dentist can or cannot do with respect to botox and dermal fillers, and what, if any, training/education is required to administer these substances. The committee did not address the political, ethical or legal aspects involved.

Dentists in B.C. are permitted to administer Botox to patients of record and as part of a dental treatment plan. Administering dermal fillers is currently outside the scope of practice for general dentists and can only be used in limited



circumstances by trained and recognized specialists. The report will be considered by CDSBC's Quality Assurance Committee.

Dental Therapists – Update

The President and Registrar met with Mr. Joe Gallagher, CEO of the First Nations Health Authority, and Mr. Daryl Beckett and Dr. Malcolm Williamson from the Ministry of Health.

One of the topics of their discussion was the need for regulation of dental therapists. The mandate of these federally funded positions is to provide care to remote communities. There are approximately eight dental therapists currently in BC, and an additional five unfilled positions, all of which are funded by the Federal Government. The responsibility for the funding and supervision of these positions will be transferred to the First Nations Health Authority by October 2013. The Province wishes that these individuals will be registered and regulated under the *Health Professions Act*. The Provincial Government



has approached CDSBC to assist in developing appropriate regulatory models. The Ministry will be sending correspondence with an official request for assistance.

The Board charged the President and Registrar to continue dialogue with the Ministry of Health and gave approval in principle to strike a task force to explore regulatory models.
