Registrar Search

The Board has hired the firm Odgers Berndtson to lead the search for a new Registrar for CDSBC. The recruiters are now in the process of accepting resumes from interested applicants.

Governance

The Board is moving forward with recommendations from a fall governance workshop led by Elizabeth Watson of Watson Advisors. The objectives of this project are to develop a comprehensive set of Board policies; to conduct a process review of CDSBC's various governance functions and revise them accordingly; and to implement recommendations for activities that will enhance good governance.

Strategic Plan: Mission, Vision and Values Approved

The Board is in the process of developing a new strategic plan for CDSBC. The mission, vision and values approved in principle are as follows:

Mission

The College of Dental Surgeons of British Columbia regulates dentists and certified dental assistants in the public interest.

It does so by establishing, monitoring, and enforcing the competent and ethical practice of dentistry, in a fair and transparent manner.

Vision

The College of Dental Surgeons of British Columbia is a leading healthcare regulator, promoting and supporting optimal health through excellence in dentistry.

Values

The College of Dental Surgeons of British Columbia is trusted because:

- We act ethically, fairly and with integrity
- We are communicative and transparent
- · We are objective and impartial
- · We are accountable

The Board is in the process of developing a new strategic plan for CDSBC.

Annual Renewal Completed

As of the March 1 renewal deadline, there are 3,266 dentists registered with CDSBC, of which 361 are specialists. The number of CDAs who renewed their certification is 5,893.

Patient Relations (Treatment of Spouses)

The College has received correspondence from dentists who feel it is appropriate to provide dental care to their spouses. We are aware that some dentists have been lobbying government in order to effect change in the current legislation. The College is required to fulfill its mandate in accordance with the governing legislation.

If CDSBC receives a written complaint about a dentist or CDA treating his or her spouse, or another patient with whom he or she has a sexual relationship, the complaint will be treated according to the established process: the College will investigate the complaint and the Inquiry Committee will assess the complaint on its own merits and as required under the HPA.

The CDSBC Board will attend a Patient Relations workshop in September to gain a better understanding of the principles behind the legislation. The workshop will be led by experts on the topic of professional boundaries, sexual misconduct and professionalism.

Infection Prevention and Control Guidelines

CDSBC is working with the College of Dental Hygienists of BC to develop revised guidelines for infection control. The draft guidelines were posted for consultation in fall 2011 and the feedback is being reviewed by both colleges. The intent is to submit the guidelines to the CDSBC Board for approval in May.

Sedation Guidelines

The College is working towards having the revised Minimal and Moderate Sedation Services guidelines to the Board at its May meeting. The intent is to ask for approval in principle, with stakeholder consultation to follow.

Dermal Fillers

Nine of the 10 provincial regulatory bodies, including B.C., have agreed to share the expense of an expert panel to do a study on the safety and training required for the safe usage of Botox and dermal fillers.

The College has made significant progress on the backlog of complaints files, closing 244 complaints in the year ending February 29, 2012.

The panel will be led by Dr. David Mock at the University of Toronto. The panel is doing the literature review now and its report is anticipated in June 2012. It will be up to each of the participating provinces to decide how to move forward based on the findings.

Complaints Backlog

The College has made significant progress on the backlog of complaints files. During the fiscal year of March 1, 2011 to February 29, 2012, CDSBC closed 244 complaints. This compares to 134 files closed in 2010/11 and 41 in 2009/10. The College opened 209 complaint files during the fiscal year ending February 29, 2012.

Approximately seven per cent of complainants apply to the Health Professions Review Board (HPRB) for review of a closed complaint file. The HPRB is an administrative tribunal that provides an independent review regarding the timeliness and disposition of complaints by BC's health colleges.

Discipline Hearing

A Panel of the Discipline Committee will conduct a hearing under section 38 of the *Health Professions Act* (HPA) concerning respondent Derek Duvall. The purpose of the hearing will be to inquire into the respondent's conduct and competence as a dentist. An amended citation was issued at the



direction of the Inquiry Committee of the College under section 37 of the HPA. The citation is available at www.cdsbc.org/discipline-hearings. Note that the patients' names are redacted to protect their privacy.

The hearing will be held from Monday, April 16 until Friday, April 27, 2012 at the Quality Inn Northern Grand Hotel, 9830 100th Avenue, Fort St. John, and from Monday, May 7 to Friday, May 11, 2012 at the Hyatt Regency Hotel, 655 Burrard Street, Vancouver. The hearing will begin each day at 9:30 am.

Prehearing applications were heard on Wednesday, February 29 in Vancouver at the Sutton Place Hotel.

Under the HPA, hearings of the Discipline Committee are open to the public. If you plan to attend the hearing, please confirm in advance by email to Nancy Crosby, Senior Assistant to the Registrar, at ncrosby@cdsbc.org. This will allow the College to ensure there is adequate seating for the public.

Annual General Meeting and Board Meeting

CDSBC's Annual General Meeting (AGM) will be held on Friday, May 25, 2012 at the Pan Pacific Hotel. The meeting will begin at 9 am. The Board Meeting will immediately follow the AGM. In accordance with CDSBC Bylaw 3.18, any 10 dentists
