Thursday, February 28 at 7 pm

Join Jack Gerrow, Registrar of the National Dental Examining Board (NDEB) for a live online town hall meeting: Demystifying the NDEB Equivalency Process. Dr. Gerrow will describe the variations in international dental education and regulation; outline the advantages and disadvantages of different approaches in determining the competence of dentists; provide an overview of the recently implemented NDEB Equivalency Process for graduates of non-accredited dental programs (which has received over 3,800 applications); and provide results for 2010 and 2011.
