## **Update on illegal dentist Tung Sheng Wu**

There has been significant public and media interest in the case of Tung Sheng (David) Wu, the unauthorized practitioner who is the subject of an investigation and court action by CDSBC.

CDSBC's lawyers will be back in BC Supreme Court to report on the search and seizure of Mr. Wu's vehicle and to ask the Court for final judgment on CDSBC's application, including sentencing. A court date has not been set.

Registrar and CEO Jerome Marburg has issued three public statements on this case. Read CDSBC's statements about the Tung Sheng Wu case here.

## **Blood-Borne Pathogen Policy**

The Board approved the Blood-Borne Pathogen Policy submitted by the Quality Assurance Committee. The policy is based on a paper commissioned by the Canadian Dental Regulatory Authorities Federation, written by a panel of experts which conducted an extensive literature review on the subject.

The policy addresses CDSBC's requirements for registrants who are infected/affected with Hepatitis B, Hepatitis C, and Human immunodeficiency virus (HIV), as well as procedures to follow in the event of an exposure incident.

The policy is designed to ensure a safe working environment and maximizes the use of measures to prevent transmission of blood-borne viruses to patients.

## Criminal Record Check – Deadline October 31, 2013

All CDSBC registrants whose criminal record check is due will receive notice in the mail this month. Criminal record checks are mandatory for all registrants in the province. Dental practitioners who do not complete their checks will not be able to renew their registration/certification in 2014.

**NEW:** The provincial government now requires that all registrants submit a legible copy of one piece of government-issued photo ID (driver's license is preferred) with their criminal record check consent form. NOTE: Faxes cannot be accepted.
