Registrant Information Session on Complaints and Discipline

CDSBC's process for investigating and resolving complaints remains a topic of considerable interest. We will be hosting an information session in Vancouver on the evening of Tuesday, **29 September 2015**. The session, which will be professionally moderated, will include a detailed explanation of the complaint/discipline process and will provide a forum to ask questions.

This session is designed for dentists, and seating will be limited to allow for a productive conversation. It will also be live-streamed. Online attendees will be able to submit questions and comments. CDSBC will be sending out a short survey in advance of the session. Discipline Hearing: Dr. Bobby Rishiraj

A panel of CDSBC's Discipline Committee has made adverse findings against oral surgeon Dr. Bobby Rishiraj of Kamloops. The panel characterized Dr. Rishiraj's conduct as incompetence.

The panel's decision follows a hearing concerning allegations that Dr. Rishiraj did not adhere to the College's sedation standards. Dr. Rishiraj admitted to some of the allegations during the course of the hearing.

A panel of the Discipline Committee will meet on Monday, **24 August 2015** to consider submissions regarding the penalty for Dr. Rishiraj. The penalty hearing will take place at 9:00 am in the Belair Room at the Sutton Place Hotel in Vancouver and is open to registrants and the public.
